9:30 Am- Pick up at Wyndham University Center - 100 Lytton Ave. Pittsburgh, Pa 15213

This iconic Pittsburgh historic landmark opened its doors to passengers in 1877 and is still operating using the same hoisting system today. We will ride the “funicular” up the side of Mt. Washington and enjoy the birds-eye view rated one of the best views in America.

10:45 am- North Shore- Hometown Heroes!! A short ride/stroll (weather permitting) along the north shore of Pittsburgh will give guests a different perspective of the city and highlight some of Pittsburgh’s most well-known hometown heroes.

11:15 am- Downtown and Pittsburgh’s Cultural District- a driving tour through the cultural district focuses on architecture and the arts.

11:30 am- Market Square- Pittsburgh’s “piazza” is Market Square. www.marketsquarepgh.com This centrally located pedestrian only square has become the “heart” of downtown. After a brief walking tour, guests will have free time for lunch (on your own) at one of the many restaurants surrounding the Square.

12:45 pm- Prantls Bakery www.prantlsbakery.com After lunch, guests will taste” the Best Cake in America” before we depart Market Square

1:00 pm- Randyland www.randy.land This Pittsburgh hidden gem and outdoor folk art museum is widely regarded as one of America’s most colorful public art displays and the “happiest place in America”.

City of Asylum www.cityofasylum.org Just a short walk from Randyland is Pittsburgh’s City of Asylum. This small yet thriving sanctuary for endangered literary writers from

around the globe transforms blighted properties into homes for exiled writers in residence.

2:00 pm- Mayfly Market and Deli- www.mayflypgh.com Before returning to the hotel, we will stop at the charming Mayfly Market for delicious scoop of locally sourced sorbet.

3:00 pm- Return to the Wyndham University Center.

I hereby agree to be solely responsible for the safety and well-being of myself and anyone under my control or supervision. I hereby understand and acknowledge that the Company is not a licensed food handler and, if food consumption is part of the Tour, does not guarantee the food’s safety and therefore shall not assume any liability related to the consumption of such food. If alcohol is served during the Tour, I agree to comply with all applicable laws regarding its consumption.

I hereby agree to comply with all rules imposed by the Company regarding my participation in the Tour. I hereby agree to conduct myself in a controlled and reasonable manner at all times. I acknowledge and agree that the Company is not responsible for property that is lost, stolen or damaged while during the Tour.
